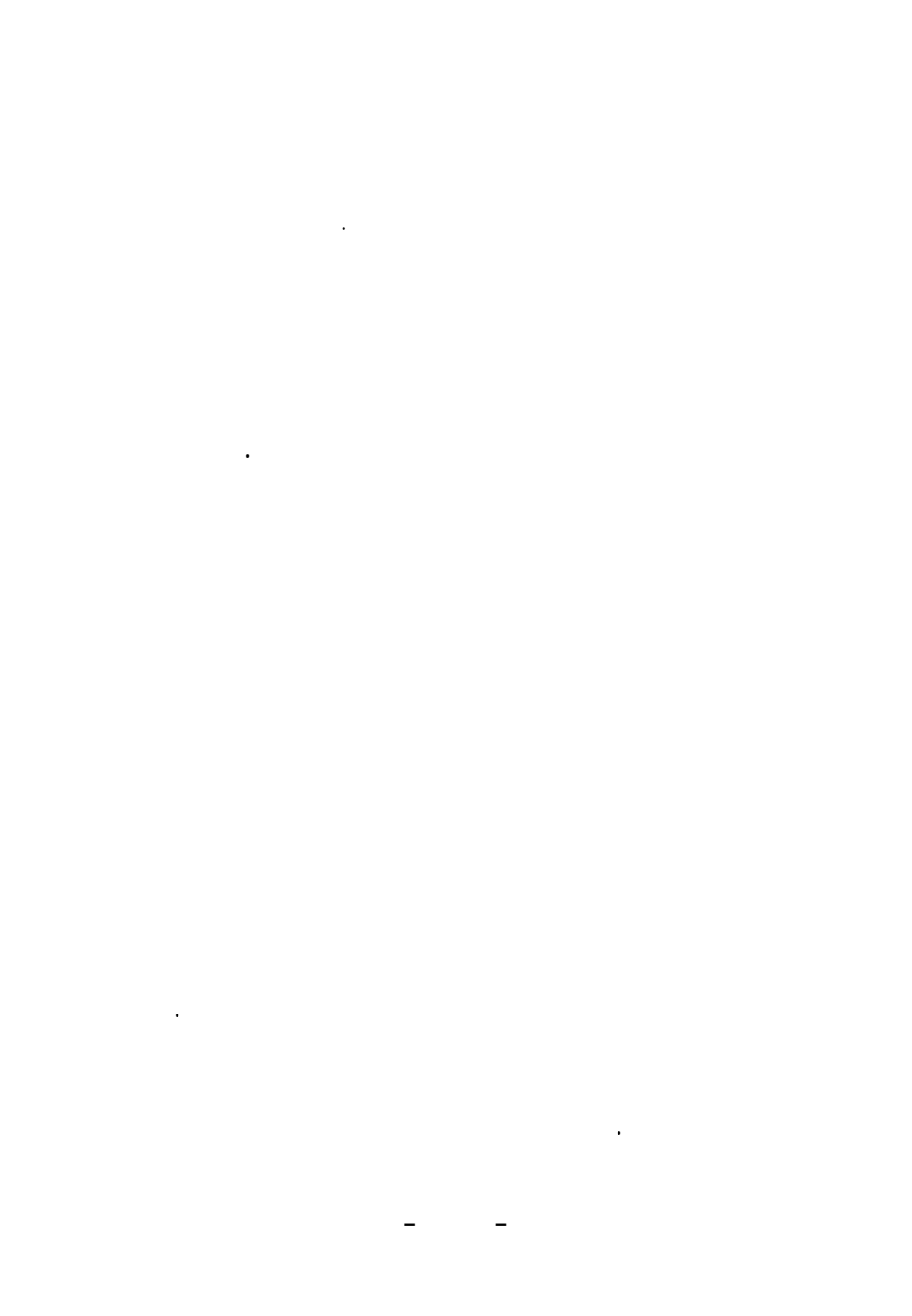

FROM PROFESSOR THE LORD ALTON OF LIVERPOOL
TO THE GOVERNOR OF SOHAG PROVINCE

October 14th 1998

Your Excellency,

I write to you once more regarding the mass detention and torture of about 1000 Christians in El-Kosheh village, Sohag province. I am deeply concerned that not only have the police officers responsible for this grave abuse of human rights not been punished but instead Bishop Wisa of Baliana, Father Antonius and Father Shenouda have been charged. They have been charged under Articles 86, 98, 171, 187, 201 and 145 of the penal code.

All that these priests were trying to do was tell the truth and seek justice for their own people and if the best that the Egyptian authorities can do is charge these priests with criminal offences it is a clear indication that the Egyptian government is itself committed to discrimination and persecution against its country's Christians and that the persecution of Christians in El-Kosheh village was not simply the actions of some biased police officers but has been carried out with the full support of the Egyptian government. It is clear from these charges against the priests that the Egyptian government is trying to intimidate the Christian clergy and stop them speaking out against religious persecution and discrimination.

If the Egyptian government is truly concerned about equal treatment for all its citizens, regardless of their religion, then it should ensure that the following action is taken as a matter of urgency: 1) Release Shaiboob William Arsal from detention and drop the false charges of murder against him. 2) Arrest the real murderers of Samir Oweda Hakim and Karam Tamer Arsal. These murderers are alleged to be some local Egyptian Muslims. 3) Punish all the police officers responsible for the detention and torture of the Christians. 4) Compensate all the Christians who were mistreated by the police.

Thank you for your attention, I do hope you will intervene and end this grave injustice.

Your Excellency,

I am extremely concerned to learn that you have been putting pressure on Bishop Wissa because of his willingness to speak out against the injustices which his people have been facing. Furthermore you have blamed him for my reference to Egyptian tourism being affected by this incident of religious persecution. I want to stress to you that Bishop Wissa never raised the issue of tourism, that was my idea and I am seriously considering pursuing an extensive campaign against Egyptian tourism if justice is not done for the Christians of Sohag soon. I am also consulting with my colleague in the United States Congress about the possibility of a joint U.S-British campaign against Egyptian tourism.

This idea of mine regarding tourism is not one I have come to lightly. But I am extremely disappointed with the Egyptian government's conduct in the Sohag affair so far. Instead of punishing the police officers responsible for the persecution of the Christians in Sohag the Egyptian authorities have charged 3 priests including Bishop Wissa and presently keep 3 Copts in detention. The 3 detained Copts are Shaiboob William Arsal, Abdu Mikhail Malak and Yasser Shahid Allam. Abdu Mikhail Malak and Yasser Shahid Allam were tortured to make them make statements accusing Shaiboob of the murder of the 2 Copts. When they tried to withdraw their statements after they were released they were simply detained again. I can assure you that I am monitoring the situation very closely and have so far seen little sincerity on the part of the Egyptian authorities in obtaining justice for the persecuted Christians. Instead the Egyptian authorities are mistreating more Copts and threatening Bishop Wissa and his priests in an attempt to cover up their mistakes.

I urge that the Egyptian authorities: 1) Release Shaiboob William Arsal. 2) Apprehend the real murderers of the 2 Copts. 3) Release Abdu Mikhail Malak and Yasser Shahid Allam, both of whom were tortured to make them give statements against Shaiboob. 4) Punish all the police officers responsible for the persecution of the Christians in Sohag. 5) Compensate all the Christians who were detained and tortured in this incident

I know that if your government has the political will, they could easily ensure that the above measures are taken. Let me assure you that the longer that we have to wait for justice for the Christians of Sohag, the more likely that there will be a strong international campaign against Egyptian tourism.

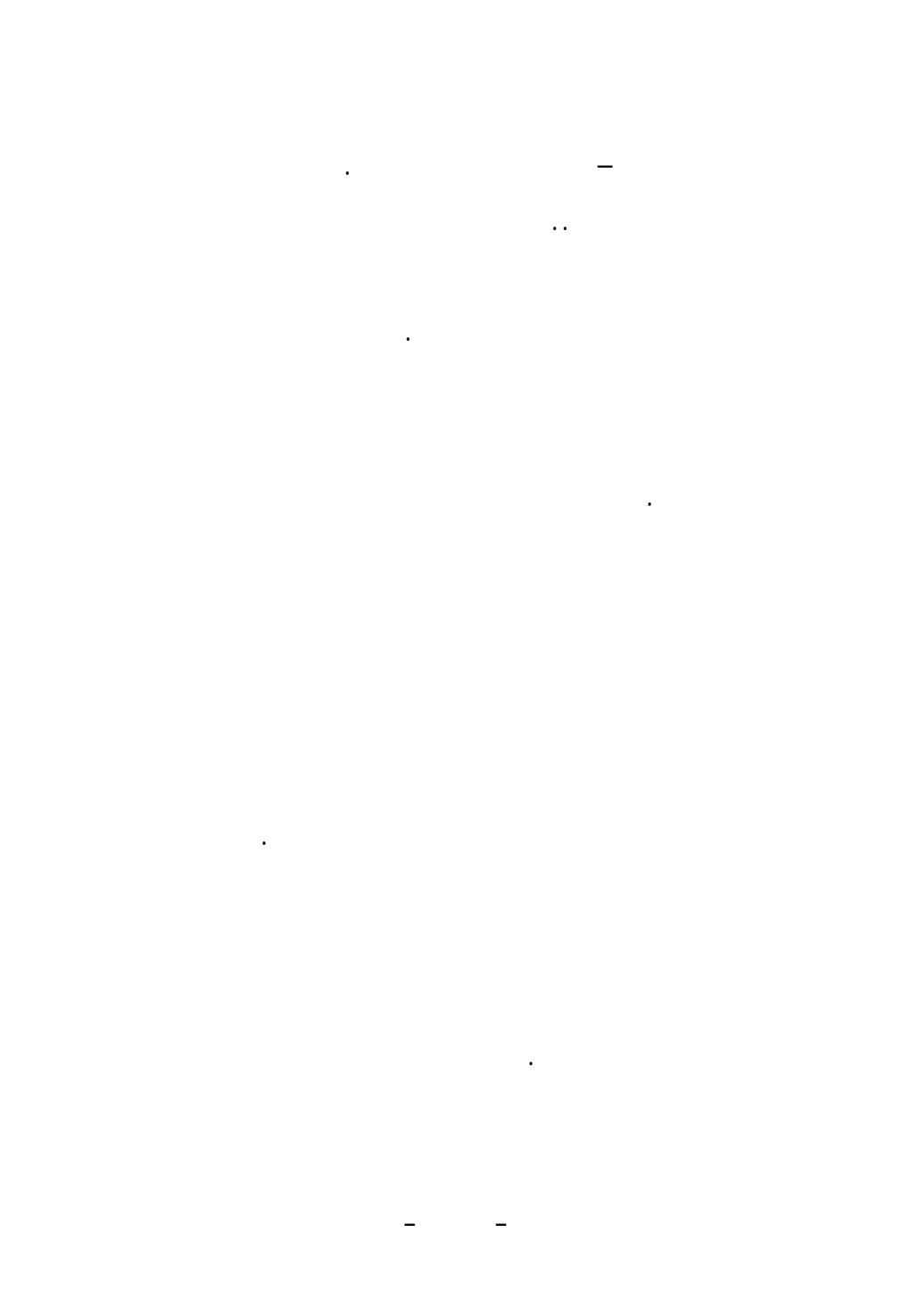

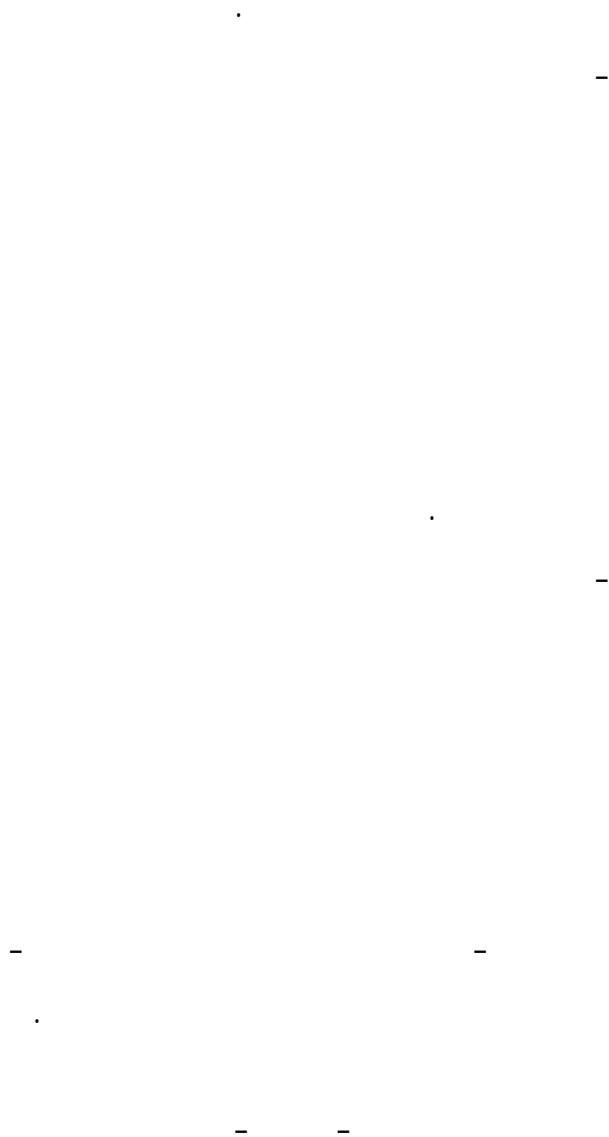
